U.S. Tobacco Settlement Revenue Securitizations Ratings Placed On CreditWatch Negative

OVERVIEW

- Tobacco settlement revenue securitizations are ABS transactions backed by tobacco settlement revenues resulting from master settlement agreement payments.
- We placed our ratings on 240 tobacco settlement revenue bonds on CreditWatch with negative implications.
- In addition, 32 other bond ratings remain on CreditWatch negative, and our outlooks on these bonds remain negative.
- The CreditWatch negative placements and negative outlooks reflect our updated view on future cigarette shipment volumes.
- The National Assn. of Attorneys General released its annual MSA domestic cigarette shipment volume data on May 3, 2019, reporting a decline of 4.75% for the 2018 sales year, which was in line with our expectations for higher declines.

NEW YORK (S&P Global Ratings) May 10, 2019--S&P Global Ratings today placed its ratings on 240 classes of outstanding tobacco settlement revenue bonds on CreditWatch with negative implications (see list).

In addition, our ratings on 32 other bonds remain on CreditWatch negative, where they were placed as a result of the downgrade of Altria (see "Ratings On 30 Classes From Seven Deals Backed By Tobacco Settlement Payments Placed On CreditWatch Negative," published Jan. 7, 2019, and "Ratings On Two Classes From Two Deals Backed By Tobacco Settlement Payments Placed On CreditWatch Negative," published Jan. 15, 2019). Furthermore, the outlooks on three bonds from Children's Trust's series 2002 remain negative.

The 272 CreditWatch negative placements, both new and maintained, reflect our updated view of annual cigarette volume declines. On May 3, 2019, the National Assn. of Attorneys General (NAAG) released its annual MSA domestic cigarette shipment volume data, reporting a decline of 4.75% for the 2018 sales year, which was in line with our recent article that discussed our updated view (see "Combustible Cigarette Volume Decline Expected to Accelerate," published April 22, 2019). In order to capture our updated view of the increased likelihood of longer-term, steeper declines in domestic cigarette shipment volumes, we plan to run an additional set of cash flow stresses that will indicate the effect, if any, on outstanding ratings. The negative outlooks on three bonds from Children's Trust's series 2002, where they were assigned on Feb. 16, 2018, reflect the uncertainty presented by the Commonwealth of Puerto Rico's state of financial emergency (see "Three Children's Trust Series 2002 Ratings Affirmed And Removed From CreditWatch Negative; Outlooks Negative, " published Feb. 16, 2018), will also reflect our updated view of volume going forward. These bonds will also be subject to the additional stress run.

Finally, our recently assigned ratings on seven bonds from Inland Empire Tobacco Securitization Authority's series 2007 already consider our updated view of future volume declines (see "Ratings Assigned To Seven Inland Empire Tobacco Securitization Authority Series 2007 Bonds," published May 10, 2019).

Before the release of the NAAG shipment volume number for the 2018 sales year, we anticipated that on a forward-looking basis, actual declines could be somewhat higher than the high-decline assumption in our criteria. This was largely based on recent developments and evolving regulations in the tobacco industry, such as current and potential vapor product growth and the consideration of legislation to increase the minimum age to purchase tobacco products (see "U.S. Combustible Cigarette Volume Decline Expected to Accelerate ," published April 22, 2019).

It is uncertain if declines in shipping volumes will be a permanent trend; thus, for the foreseeable future, we will run the updated volume decline scenario as an additional stress along with our current volume decline assumptions from the criteria. We will analyze the impact of this stress on all of our outstanding rated tobacco settlement revenue transactions as a way of capturing the effect on cash flow results if shipment volumes continue to decline at an accelerated rate in the future.
