Governor DeWine's Capital Improvements Budget

Chairmen Oelslager and Callender, Vice Chair Scherer, Ranking Member Cera, and members of the Finance Committee, my name is Kim Murnieks, and I am Director of the Office of Budget and Management. I am pleased to be with you today to present Governor DeWine's Capital Improvements Budget for fiscal years 2021 and 2022.

The capital budget will make appropriations for the renovation, reconstruction, and construction of capital assets of state agencies, colleges, universities, and school districts. It also funds a program of grants and loans to local governments for infrastructure projects throughout the state. Additionally, a portion of appropriations in the capital budget will provide funds to support targeted projects of local or regional importance.

The \$2.0 billion in capital appropriations in this proposal, along with the \$512.5 million appropriated for the Public Works Commission and the Ohio Facilities Construction Commission in Senate Bill 4, total \$2.5 billion in GRF bond funded appropriations for the FY 2021-2022 capital biennium. The capital appropriations recommended are manageable and affordable within our current and future budget capacity, keeping the State well under the constitutional five percent limitation on debt service as a percent of revenue. In fact, OBM anticipates that our debt service will continue to be below four percent of the state's annual GRF plus lottery proceeds. The size of the recommended capital budget supports the credit rating agencies' metric that currently views Ohio's debt burden as moderate and affordable. The State has held stable, high-quality investment ratings from the three main rating agencies for more than twenty years. Our general obligation bonds carry the second highest possible credit ratings.

Most of the appropriations in this proposal are supported by long-term debt issued by the State of Ohio, with the principle and interest payments funded by General Revenue Fund (GRF) appropriations made in operating budgets. Ohio continues to take advantage of a historically low interest rate environment on new debt issuances. For example, the state's \$200 million bond sale yesterday for previously appropriated Infrastructure and Conservation projects priced at an interest cost of 1.68 percent. Typically, OBM issues debt no more than 18 months in advance of the proceeds being spent, so we anticipate that the full \$2.5 billion to be authorized in this capital biennium would be borrowed over the next four to five fiscal years.

The recommended capital plan is being presented for your consideration following a careful

process that has prioritized the most pressing needs of state government, K-12 schools and higher education institutions, with particular emphasis given to each project's impact on jobs and economic growth. Most of the proposed capital spending is focused on sustaining and improving the state's current capital assets.

Placing jobs and economic growth as the priority, the capital budget can be viewed as a jobs bill intended to grow Ohio's economy during these unprecedented times. In Ohio, employment numbers show that construction is one of the top 10 private industries in terms of employing workers and serves as a major contributor to our economy.

FYs 2021 and 2022 Capital Appropriations

The capital budget contains \$2.1 billion in appropriations, with \$2.0 billion of that amount supported by GRF-backed debt obligations and the remaining \$112.7 million supported by non-GRF-backed bonds and cash funds. Table 1, attached to my testimony, provides a detailed breakdown of capital appropriations by agency and funding source.

I would now like to take a few minutes to highlight some of the recommendations.

Higher Education Institutions and Statewide Higher Education Projects

The capital budget includes \$452 million for the Department of Higher Education and for colleges and universities across the state. The Governor asked the higher education community to develop a collaborative capital funding request prioritizing the needs of the entire university system ahead of the desires of individual institutions. Led by the Inter-University Council of Ohio and the Ohio Association of Community Colleges, they delivered a strategic, comprehensive capital funding plan endorsed by each of the state's public higher education institutions.

In addition to campus-specific allocations, there are several projects of statewide benefit recommended in the budget for the Department of Higher Education. These include:

- \$14 million to support the Ohio Academic Resources Network (OARnet), which serves as the broadband backbone for the state connecting Ohio's education, healthcare, public broadcasting, and government entities;
- \$7.6 million to support the acquisition of Workforce Based Training and Equipment, commonly known as RAPIDS grants, that are used to purchase state-of-the-art equipment to address specific regional workforce needs; and
- \$7.2 million to support the Ohio Supercomputer Center by securing sensitive systems and replacing end-of-life technology.

Ohio Facilities Construction Commission

The Ohio Facilities Construction Commission (OFCC) administers the state's K-12 school building construction program, which provides state support to assist local school districts in the construction and renovation of Ohio's primary and secondary education facilities.

The capital budget provides \$300 million in spending authority for the continuation of the K-12 school program, the energy conservation program, and the state building assessment and

planning program in the upcoming capital biennium. With this appropriation level, the OFCC will continue funding 41 districts with projects currently in process and offer funding to additional school districts based on rankings of need in statute. The K-12 capital appropriations recommended are in addition to the \$300 million in School Building Program Assistance approved by the General Assembly in Senate Bill 4, which was effective October 13.

\$10 million for Strong Ohio Safety Grants

The capital budget includes \$10 million for Strong Ohio Safety Grants, with \$5 million to be appropriated for colleges and universities through the Ohio Department of Higher Education and \$5 million appropriated for Ohio's K-12 schools through OFCC. These competitive grant programs will be administered in coordination with the Department of Public Safety. Colleges, universities, and schools will submit a vulnerability assessment conducted by experienced security, law enforcement, or military personnel and will be required to describe how the grant will be used to address the vulnerabilities identified in the assessment. Applications will also describe how the grant will be used to integrate organizational preparedness with broader state and local preparedness efforts.

Ohio Public Works Commission

The Ohio Public Works Commission provides financing for local public infrastructure needs through the State Capital Improvement Program (SCIP) which has been approved by voters four times, most recently in May of 2014. Senate Bill 4 provided appropriations totaling \$255 million. This budget continues support for this program and includes \$280 million in appropriations for PWC - \$237.5 million in GRF-backed debt appropriations and \$42.5 million in Revolving Loan Fund appropriations. \$200 million of the GRF-backed appropriations will be used to provide grants and loans to local governments for infrastructure projects such as roads and bridges, water supply and wastewater treatment systems, storm water collection, and solid waste disposal. The \$42.5 million in Revolving Loan Fund appropriations uses the proceeds of repayments from past loans to make additional loans to local governments for these same types of local infrastructure projects. Also included in the PWC appropriation is funding for the Clean Ohio Green Space Conservation Program which I will now discuss.

Clean Ohio Fund

The recommended capital budget includes \$62.5 million in new appropriations for the Clean Ohio Program within the budgets of three state agencies, with \$37.5 million provided for the Public Works Commission's Green Space Conservation Program to fund the preservation of open spaces, sensitive ecological areas, and river and stream corridors. This is in addition to the \$37.5 million appropriated in Senate Bill 4. Both the Department of Natural Resources' Clean Ohio Trails Program and the Department of Agriculture's Easement Purchase Program are provided with \$12.5 million. The Department of Natural Resources applies these funds to improve outdoor recreational opportunities by funding trail development. The Department of Agriculture uses Clean Ohio funding to purchase agricultural easements from landowners who volunteer to keep their land in agricultural production in perpetuity.

State Agency Capital Appropriations

The following are notable agency appropriations contained in the proposed capital budget:

Department of Mental Health and Addiction Services

The public behavioral health system in Ohio serves as a safety net for the uninsured and impoverished, as well as for individuals needing specialized care. One of the Department of Mental Health and Addiction Service's core functions is to provide administrative oversight to the six state psychiatric hospitals and the Moritz maximum security facility, as well at the state pharmacy. Across all six hospitals, the Department maintains 1,065 beds and admitted 5,896 individuals for treatment in fiscal year 2019 while providing over 390,000 bed days of service. Collaboration with local Alcohol, Drug Addiction, and Mental Health Services (ADAMHS) Boards allows the Department to reach deep into the community to provide the necessary infrastructure to facilitate ease of access to care at that level.

The recommended capital budget provides \$95.6 million in new appropriations for the Department of Mental Health and Addiction Services to fund the general renovations at the state psychiatric hospitals and our continued support of community recovery housing and program space for the mentally ill and drug addicted.

Department of Rehabilitation and Correction

The Department of Rehabilitation and Correction (DRC) has a current inmate population of 44,598 across 28 different facilities. DRC also funds 19 Community-Based Correctional Facilities (CBCF), which serve as secure residential treatment programs for felony offenders and help divert low level felons from prison. CBCFs served 8,047 offenders during fiscal year 2019. Lastly, DRC operates three halfway houses, which provide transitional supervision and services to offenders as their sentences come to an end.

The capital budget provides \$280.7 million in new appropriations for the Department of Rehabilitation and Correction to support several major facility renovations as well as general improvements at the 27 state-owned adult correctional institutions.

\$50 million for Grants for Construction and Renovation of Local Jails

Included in the DRC capital budget is a \$50 million grant program to support construction and renovation of local jails. In recommending a jail funding amount, DRC reviewed jail conditions using the data that the Bureau of Adult Detention (BAD) collects during inspections. The capital budget as proposed will provide \$50 million for DRC to competitively award funds to counties with the greatest need based on DRC review, the ability to improve safety, and shared use amongst multiple counties.

Department of Administrative Services

The recommended capital budget includes a total of \$51 million for the Department of Administrative Services, including \$18 million in GRF-backed debt and \$33 million from non-GRF cash funds. The recommended appropriations provide \$11 million for continued implementation of secure identity management for agency websites and applications and to enable agency data sharing and data analytics capabilities. The Governor's proposal also includes \$7.1 million to replace aging MARCS tower infrastructure and construct new towers when needed. Finally, the recommendation includes \$33.1 million for planned improvements at state office buildings and the State of Ohio Computer Center. This includes replacements and upgrades for heating and cooling systems, elevators, electrical power supply, and fire suppression systems.

Department of Natural Resources

The solace of nature was never more essential than in this year when millions of Ohioans found escape from the challenges of a global pandemic by taking advantage of outdoor recreation, parks, and waterways. The Ohio Department of Natural Resources has an expansive footprint with properties in all 88 counties. Many ODNR facilities and their underlying infrastructure are decades old, some even more than a century old. This capital budget provides ODNR with \$253 million to preserve the safety of Ohioans and protect critical infrastructure such as dams and wastewater treatment facilities. This capital budget also supports necessary upgrades and infrastructure improvements for the campgrounds and cabins that hosted record numbers of visitors throughout the spring, summer, and fall of this year. The capital investment in these properties will allow ODNR to continue to safely provide high-quality recreational experiences for all visitors.

Community Projects

The DeWine-Husted Administration is committed to ensuring that Ohio communities thrive and we are working in cooperation with the leadership of the General Assembly to focus capital funding for targeted projects of local or regional importance similar to recent capital budgets. During the last several months, community representatives throughout the state worked with the Administration and legislators to identify priority projects in every region. As a result of this process and collaboration with state legislators and the Administration, the capital budget will include several projects that have strong community support, most of which also include commitments of local resources.

Conclusion

Mr. Chairman, members of the Committee, I appreciate the opportunity to present Governor DeWine's Capital Improvements Budget for Fiscal Years 2021 and 2022.

I want thank Governor DeWine and his staff, Lt. Governor Husted, all members of the Governor's Cabinet, and especially the staff of OBM who developed the proposal that I am happy to present today. We look forward to working together with each of you as the General Assembly considers this proposal.

As I mentioned earlier, the capital budget is intended to help grow our economy during these challenging times and to allow Ohio businesses to retain and grow jobs. Additionally, without a capital budget, agencies would have no choice but to turn to operating funds for things like critical renovations and safety projects that could otherwise be funded with capital funds. Delaying investment can add to future costs.

I thank you, Mr. Chairman, and members of the Finance Committee, for your time and consideration today. I am happy to answer your questions.

Dear Chancellor Gardner,

It is with gratitude and pleasure that we submit our recommendations for capital funding for Ohio's community colleges.

Through various iterations of this capital appropriations process our top priority, like yours and Governor DeWine's, has been to protect, maintain, and fully utilize our current capital assets for the benefit of Ohio's students, businesses, and communities. In our submission, we are proud to embrace the Governor's priorities and recommend that all of this year's capital funding be used to renovate, repair, and expand academic space of *existing* campus facilities, with only a few exceptions.

You will notice the majority of the our requests are dedicated to protecting the state's prior investments in our facilities, not wholesale renovations of entire buildings as is more often seen with other capital funding requests. Instead, our requests are a variety of patchwork deferred maintenance repairs for heating, electrical, and plumbing systems, roof and window replacements, upgrades to individual classrooms and labs, parking and pedestrian safety, and improvements to campus security systems.

As higher education leaders, we believe that the current system of how capital funds are allocated is in dire need of an update, and we are very appreciative that the DeWine Administration has agreed to listen to these concerns. While the state's universities have funded their capital needs through an approach that relies heavily on issuing local debt often backed through student fees, our cost structure and mission does not allow us that option if we wish to remain affordable and accessible to those Ohioans who need us most. Because of our more limited resources, our colleges rely far more on direct state capital support to help our ongoing maintenance needs while also providing updated facilities, equipment and technology necessary to help prepare a locally trained workforce for the modern economy.

While the state capital funding allocation may have made sense decades ago when it was first established, it now produces severely inequitable outcomes throughout the system. This longstanding way of allocating capital funds has led to examples in communities across the state where the institution of higher education that serves fewer students actually receives substantially more in state funding than the one that serves more local residents.

As you are aware, this is not a new concern for our sector. The overall allocation of capital funds compared to the needs and available resources has been a topic raised by OACC for the past several capital budget cycles. Unfortunately, every time the request for a comprehensive study of our capital needs and utilization is raised, that request has either been tabled for a later time or simply ignored. That is why we cannot stress enough how much we appreciate the willingness of the DeWine Administration to start discussing these funding inequities.

We are grateful for the Governor's leadership and support on so many issues facing community colleges during his first year in office, but none more so than his unprecedented embrace of our core mission to fill the workforce needs of the employers in the communities we serve. By signature below, the Presidents of Ohio's community colleges affirm our approval of the attached recommendations and express sincere gratitude for the continuing support of the DeWine Administration.
