
Ohio Revised Code 107.03

Actual agency expenses by source of funds during each fiscal year of the previous two biennia shall be presented in comparative form, per Ohio Revised Code Section 107.03. This section meets the requirement of ORC 107.03.

Ohio Department of Human Services

In an effort to reduce duplicative services and to create an integrated statewide workforce development system, the Taft administration consolidated the Department of Human Services and the Bureau of Employment Services, creating the Department of Job and Family Services. The new department came into existence on July 1, 2000.

State and Local Government Commission

The State and Local Government Commission (SLG), established in 1978, worked with local governmental entities throughout the state to help resolve intergovernmental problems and assisted with identifying funding sources for local projects. The agency also maintained the Directory of State Services for Local Government, kept an up-to-date database of elected officials, published a quarterly newsletter that provided information on state and federal legislation with impacts on local governments, and published the State of Ohio toll-free telephone number list.

Amended Substitute House Bill 94 of the 124th General Assembly eliminated the commission in fiscal year 2002.

Women's Policy and Research Commission

The Women's Policy and Research Commission (WPR) was established in 1990 with a mission to promote the advancement of women and the removal of barriers to women's equality by maintaining a list of women qualified for state appointments, educating the public on the status of women, assisting the public and private sectors with the development of programs and services for women, identifying barriers to women's equality, and analyzing current and proposed public policy and reporting its impact on women.

Amended Substitute House Bill 94 of the 124th General Assembly eliminated the commission in fiscal year 2002.
